## What is this product?

### TYPE

The product is a sub-fund of Planetarium Fund, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

### TERM

The Sub-Fund is established for an unlimited duration. However the Board of Directors may decide to close this product under certain circumstances.

### OBJECTIVES

The Sub-Fund aims to increase the value of the capital invested.

The Sub-Fund is actively managed without any reference to a benchmark. The Investment Manager has discretion over the composition of its portfolio subject to this objective and investment policy.

The Sub-Fund focuses primarily on investing in bonds issued by companies in the financial sector. The proportion of such investments can vary according to market conditions and in accordance with the flexible management style of the Sub-Fund.

The Sub-Fund can invest up to 100% of its net assets in bonds and money-market instruments of either sovereign or corporate issuers, with any rating or with no rating, and up to 20% of the net assets in equity instruments, depending on the decisions taken by the Investment Manager. The Sub-Fund can invest up to 20% of the net assets in bank deposits and up to 10% in UCITS and other UCIs in compliance with the applicable regulations. The Sub-Fund may invest up to 40% in contingent convertible bonds. A contingent convertible bond is a debt security, issued by banks or financial institutions that upon a pre-specified triggering event converts into a set number of shares, or is subject to a partial or full write-off. Triggering events include pre-defined capital ratios of the issuer falling to a particular level, or the issue/issuer being subject to a regulatory action or decision by the responsible regulator in the issuer's home market.

The Sub-Fund has a flexible investment style so the portion invested in the finance sector can be variable over time. As far as equity is concerned, the investments are made in stocks of mid- and large-cap companies, diversified in all sectors.

The investments are made in financial instruments denominated in EUR or other currencies traded on regulated markets of OECD countries or main Emerging Market countries.

The Sub-Fund may use derivative financial instruments mainly for hedging risks and efficient portfolio management, but also for investment purposes.

The Investment Manager implements an investment policy that can vary significantly between the geographical, sectorial asset allocation and the ratio between investments in stocks (within the limits stated above), bonds and money-market instruments.

The Sub-Fund may hold Ancillary Liquid Assets (up to 20% of its net assets) in order to cover current or exceptional payments or for the time necessary to reinvest those Ancillary Liquid Assets in eligible assets.

The Sub-Fund will not use any SFT or TRS.

Sale of shares in the Sub-Fund can be made on any business day.

Any income arising from the Sub-Fund's investments is reinvested and reflected in the value of your shares.

### INTENDED RETAIL INVESTOR

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 3 years.

## What are the risks and what could I get in return?

### Risk indicator



The risk indicator assumes you keep the product for 3 years.

## What happens if Lemanik Asset Management S.A. is unable to pay out?

Lemanik Asset Management S.A. is not making any payment to you in relation to this Sub-Fund and you would still be paid in case of a default from Lemanik Asset Management S.A.

The Sub-Fund's assets are held with BNP Paribas, Luxembourg Branch and are segregated from the assets of other sub-funds of the Company. The assets of the Sub-Fund cannot be used to pay the debts of other sub-funds of the Company.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

(\*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 3.9% before costs and 0.6% after costs.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

The performance fee is calculated and accrued on a daily basis. It is crystallized on daily basis and paid at the end of each calendar month. However, any underperformance of the sub-fund has to be recouped before a performance fee can be paid. The actual amount will vary depending on how well your investment performs. ## How long should I hold it and can I take my money out early?

### Recommended holding period: 3 years.

The recommended holding period was chosen to provide a consistent return less dependent on market fluctuations.

Redemptions are possible at any time and without limitation. All redemption requests must be received in good order by the Registrar and Transfer Agent prior to 2 p.m (Central European time) on one (1) Business Day (any bank business day in Luxembourg) preceding the relevant calculation day of the NAV. Redemption proceeds shall be paid in the relevant reference currency usually within two (2) Business Days following the relevant calculation day of the NAV.

## How can I complain?
