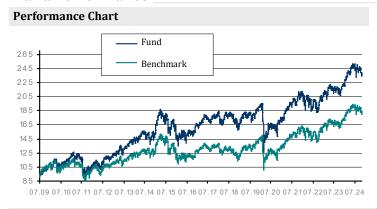
Fund Philosophy
