Fund Philosophy

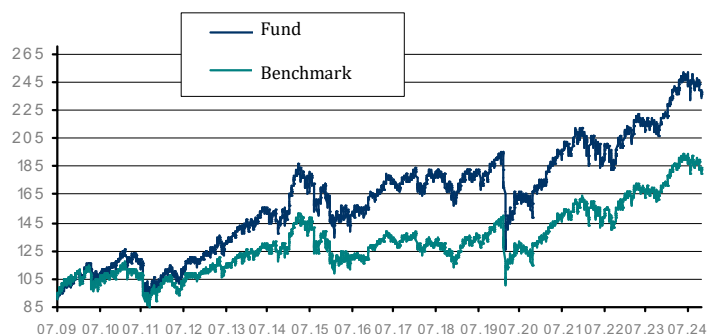
