Fund Philosophy

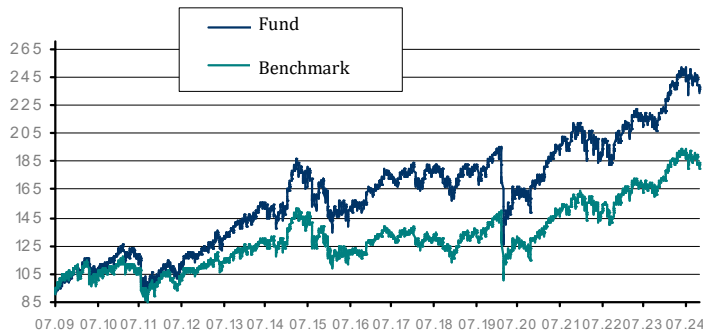
